What is this product?

This product is a unit of a mutual fund qualifying as an undertaking for collective investment in transferable securities (UCITS).

This sub-fund has no maturity date. However, the management company may decide to close the sub-fund under certain circumstances.

The sub-fund aims to generate a long-term capital growth by investing primarily in company shares (equities) incorporated or active in People's Republic of China.

In order to achieve its objective, the sub-fund mainly invests in company shares (equities) or instruments related to company shares domiciled in China and listed on Shanghai and Shenzhen (China A-Shares, China B-Shares), Hong Kong (H-Shares, Red Chips, P-Chips) and in the US (ADRs), or in any regulated market in an OECD country outside China as long as a significant portion of the company's assets or revenues are based or derived from China.

The sub-fund invests on stock exchanges or on other regulated markets, which are recognized, open to the public and operate regularly.

The sub-fund is aiming at a diversified portfolio, with no particular focus on a specific industrial sector.

The sub-fund may invest in derivative instruments in order to mitigate risks.

The sub-fund may invest in cash deposits or money market instruments on ancillary basis and up to 100% of its assets in exceptional market conditions and on a temporary basis only.

The sub-fund qualifies as an Article 8 financial product under SFDR (Sustainable Finance Disclosure Regulation). applied is information about the ESG characteristics available online at the website of the Investment Manager: www.agcm.se/en/documents/sustainability.

Benchmark: The portfolio is actively managed on a discretionary basis without reference to a benchmark.

Intended retail investor

This product is offered to investors who may have basic or no knowledge and experience of investing in financial markets and also experienced investors. An investment in this product is designated to be a medium term investment and the investment horizon should ideally be at least three to five years. Investors should not expect to obtain short-term gains from such investment.

Other information

Depositary: Skandinaviska Enskilda Banken. AB (publ) - Luxembourg

Dividend income: This class is a capitalisation class meaning that income is reinvested.

Conversion right: The investor has the right to convert his investment in units in one sub-fund for units in the same sub-fund or in another sub-fund. The investor can obtain information about how to convert in the prospectus of the fund.

Segregation: The assets and liabilities of a sub-fund are segregated pursuant to the law so that the commitments and liabilities of one subfund do not affect the other sub-funds.



What are the risks and what could I get in return?

Risk indicator



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 5 out of 7, which is a mediumhigh risk class.

This rates the potential losses from future performance at a mediumhigh level, and poor market conditions will likely impact our capacity to pay you.

Be aware of currency risk. You may receive payments in a currency that differs from your reference currency, so the final return you will get depends on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.

What happens if FundRock Management Company S.A. is unable to pay out?

The Management Company is responsible for administration and management of the sub-fund, and does not typically hold assets of the sub-fund (assets that can be held by a depositary are, in line with applicable regulations, held with a depositary in its custody network). The Management Company, as the PRIIPS manufacturer has no obligation to pay out since the product design does not contemplate any such payment being made. However, investors may suffer loss if the sub-fund or the depositary is unable to pay out. There is no compensation or guarantee scheme in place which may offset, all or any, of this loss.

What are the costs?

Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. Recommended holding period: 5 years
