# WHAT IS THIS PRODUCT?

Type: This product is a Fund of Baron Capital UCITS ICAV, an Irish collective asset management vehicle constituted as an umbrella fund with segregated liability between Fund's and authorised by the Central Bank of Ireland pursuant to the European Communities Regulations 2011.

The Funds investment objective is to seek to achieve an attractive capital appreciation over the long term.

Objectives: The Fund seeks to achieve its investment objective by investing primarily in equity securities in developed and emerging markets

located throughout the world, issued by companies across all capitalisations

Asset classes which may be issued, listed or traded on recognised markets include equity securities of companies of any sector or industry classification, which may include common stocks, depositary receipts (American Depositary Receipts, European Depositary Receipts or Global Depositary Receipts) and related securities such as preferred stocks, real estate investment trusts ("REITs"), private placement securities, subscription rights, warrants, equity-linked notes, unlisted equity securities, initial public offerings (IPOs), secondary offerings, Rule 144A or Regulation S securities (securities offered outside of the US but which are exempt from the registration requirements of Section 5 of the US Securities Act of 1993), partnership interests (interests in partnerships traded on a recognised securities exchange) and convertible securities

In addition, the Fund may invest in collective investment schemes (including exchange traded funds) which are themselves exposed to investments that are similar to the Funds other investments. Such collective investment schemes may or may not be managed by the Investment Manager or its affiliates and will comply with the requirements of the UCITS Regulations in respect of such investments. The Fund may have exposure to China "A" shares directly via Shangai-Hong Kong Stock Connect or Shenzhen-Hong Kong Stock Connect. The Fund may also invest in equities and equity related securities based in India.

The Fund will not enter into repurchase agreements or reverse repurchase agreements.

The Fund does not expect to enter into securities lending transactions, but may do so up to 25% of its Net Asset Value.

The Investment Manager's approach to identifying equity securities is fundamental, bottom-up, and research driven.

The Investment Manager identifies companies it believes have strong fundamentals, regardless of the macroeconomic environment and seeks to identify whether companies have the following criteria; significant growth potential, durable competitive advantages, exceptional management and compelling valuations relative to the Investment Manager's projections of intrinsic value.

Distribution Policy: Net investment income on the Funds investments attributable to each Share Class is expected to be retained by the Fund, which will increase in the Net Asset Value per Share of the relevant Class. The Directors retain the right to declare dividends in their sole discretion. In the event that dividends are declared in respect of any Class of Shares, Shareholders will be notified in advance, including the date by which distributions will be paid.

The Fund launched on 31 August 2023. The Share Class launched on 31 August 2023.

The currency of the Fund is USD, the currency of this product is EUR. You can buy, sell and convert your shares monthly. The minimum initial investment for this share Class is USD 1,000.

The Fund is actively managed and does not track or seek to replicate the composition of any index or benchmark.

Intended retail investor:

Investment in the Fund is suitable for knowledgeable investors who are seeking capital appreciation over the long term but who understand and can accept fluctuations in the value of the investments over the short term, which may temporarily even lead to a scenario of substantial loss of value.

# Risk indicator





The risk indicator assumes you keep the product for 7 years. The actual risk can vary significantly if you cash in at an early stage and you may get back less.

### WHAT ARE THE COSTS?

#### Cost over time

The tables below show the amounts that are taken from your investment to cover different types of costs.
