WHAT IS THIS PRODUCT?

Type : This product is a share of an investment company qualifying as an undertaking for collective investment in transferable securities (UCITS).

Term : This product has no maturity date. However, the Board of Directors may decide to close the product under certain circumstances.

Objectives : The Fund seeks to achieve capital appreciation and income generation by investing primarily in onshore RMB denominated equity securities issued by users based in, or having a significant exposure to, the People's Republic of China ("PRC") and the Hong Kong S.A.R. The Fund is an actively managed UCITS where the manager has discretion over the composition of its portfolio, subject to the stated investment objectives and policy. The Investment Manager holds a QFI license to invest in the PRC. The Investment Manager also contemplates investing directly into China A-Shares using the Stock Connect. The investments using Stock Connect will be limited to China A-Shares listed on the SSE and the SZSE. The Fund will invest at least 70% of its net asset value in China A-Shares listed on the SSE or the SZSE through the QFI status of the investment Manager and through Stock Connect. As part of these primary investments in China A-Shares, the Fund may invest more than 30% of its net asset value in China A-Shares listed on SZSE ChiNext Market or SSE STAR Market. The Fund may invest no more than 10% of its net asset value in fixed income securities issued and/or guaranteed by any single country (including its government or a public or local authority of that country) with a credit rating below the investment grade. The Fund will also invest no more than 10% of its net asset value in units of UCITS and other UCIs, including China A-Share Funds and RMB Debt Securities Funds.

The Fund launched on 28 November 2014. The Share Class launched on 13 January 2015.

The currency of this Fund is USD, the currency of this product is RMB.

Distribution Policy: Returns and gains are not distributed but are reinvested in the Fund.

Intended retail investor : The Company is offered to investors who may have basic or no knowledge and experience of investing in financial markets and also experienced investors and is intended for long-term investment. Investors should understand the risks involved, including the risk of losing all capital invested and must evaluate The Company's objective and risks in terms of whether they are consistent with their own investment goals and risk tolerances.

WHAT ARE THE RISKS AND WHAT COULD I GET IN RETURN?

Risk indicator



The risk indicator assumes you keep the product for 5 years. The actual risk can vary significantly if you cash in at an early stage and you may get back less.

You may not be able to sell your product easily or you may have to sell at a price that significantly impacts on how much you get back.

We have classified this product as 5 out of 7, which is a medium-high risk class. This rates the potential losses from future performance at a medium-high level, and poor market conditions will likely impact our capacity to pay you.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

Be aware of currency risk. You will receive payments in a different currency, so the final return you will get depends on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.

Investors shall note that besides the risks included in the risk indicator, other risks such as Risk relating to China A-Share market, PRC Tax Risk, RMB Currency and Currency Conversion Risks, QFI Regime Risk, Risk linked with dealing in securities in China via Stock Connect, Risk associated with ChiNext market and/or the Science and Technology Innovation Board ("STAR Market") and Risk associated with Sustainability Risk may affect the Fund's performance.

This product does not include any protection from future market performance so you could lose some or all of your investment. If not able to pay you what is owed, you could lose your entire investment.

Performance scenarios

What you will get from this product depends on future market performance. Market developments in the future are uncertain and cannot be accurately predicted.

Unfavourable scenario: This type of scenario occurred for an investment between August 2021 and December 2022.

However, investors may suffer loss if the Fund or the depository is unable to pay out. There is no compensation or guarantee scheme in place which may offset, all or any, of this loss.

WHAT ARE THE COSTS?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

Cost over time

The tables below show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- In the first year you would get back the amount that you invested (0% annual return)
- For the other holding periods we have assumed the product performs as shown in the moderate scenario
- 10,000 CNH is invested

HOW LONG SHOULD I HOLD IT AND CAN I TAKE MY MONEY OUT EARLY?

The recommended minimum holding period: 5 years.
