## What is this product?

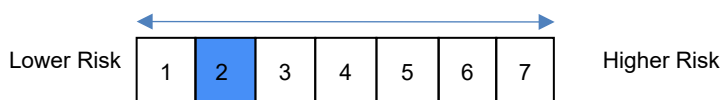
**Term**  
The Fund does not have maturity date.  
The PRIIP Manufacturer may not terminate the Fund unilaterally.  
Fund can not be automatically terminated.

**Objectives**  
To seek current income. Under normal circumstances, the Sub-Fund invests mainly in a broad range of government and corporate bonds from anywhere in the world, including emerging markets. It may also invest up to 100% of its assets in asset-backed securities (ABS) and mortgage-backed securities (MBS). The Sub-Fund aims, without guarantee, to maintain an effective duration (a measure of interest rate sensitivity) ranging from 0 to 3 years.  
The Sub-Fund may use derivatives for hedging (reducing risk) and to seek investment gains.  
The Sub-Fund is actively managed. The Sub-Fund is not managed in reference to a benchmark.

**Intended Retail Investor**  
The Fund is suitable for investors with basic investment knowledge that seek current income through debt securities and with a medium to long term investment horizon of at least 3 years. The Fund has specific and generic risks with a risk rating as per the SRI number, all detailed in the prospectus.

## What are the risks and what could I get in return?

### Risk Indicator



The risk indicator assumes that you keep the product for 3 years. The actual risk can vary significantly if you cash in at an early stage and you may get back less.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

This rates the potential losses from future performance at a low level, and poor market conditions are very unlikely to impact the capacity of the PRIIPs manufacturer to pay you.

We have classified this product as 2 out of 7, which is a low risk class.

**If the product currency differs from your investment currency, the following applies: Be aware of currency risk. You will receive payments in a different currency, so the final return you will get depends on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.**

## Performance Scenarios

The figures shown include all the costs of the product itself, and includes the costs of your advisor or distributor. The figures do not take into account your personal tax situation, which may also affect how much you get back.

What you will get from this product depends on future market performance. Market developments in the future are uncertain and cannot be accurately predicted.

The unfavourable, moderate, and favourable scenarios shown are illustrations using the worst, average, and best performance of the product and a suitable benchmark over the last 10 years. Markets could develop very differently in the future.

The stress scenario shows what you might get back in extreme market circumstances.

The unfavourable scenario occurred for an investment in the benchmark between April 2017 and April 2020.

The moderate scenario occurred for an investment in the benchmark between July 2015 and July 2018.

The favourable scenario occurred for an investment in the benchmark between August 2013 and August 2016.

## What happens if FundRock Management Company S.A. is unable to pay out?

## What are the costs?

### Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest and how long you hold the product. We have assumed:

- In the first year, you would get back the amount that you invested (0 % annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario.

### Recommended holding period: 3 years
