What is this product?

Type

Objectives

To seek current income. Under normal circumstances, the Sub-Fund invests mainly in a broad range of government and corporate bonds from anywhere in the world, including emerging markets. duration (a measure of interest rate sensitivity) ranging from 0 to 3 years.


The Sub-Fund may use derivatives for hedging (reducing risk) and to seek investment gains.

Intended Retail Investor

The Fund is suitable for investors with basic investment knowledge that seek current income through debt securities and with a medium to long term investment horizon of at least 3 years. The Fund has specific and generic risks with a risk rating as per the SRI number, all detailed in the prospectus.

Risk Indicator



The risk indicator assumes that you keep the product for 3 years. The actual risk can vary significantly if you cash in at an early stage and you may get back less.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

This rates the potential losses from future performance at a low level, and poor market conditions are very unlikely to impact the capacity of the PRIIPs manufacturer to pay you.

We have classified this product as 2 out of 7, which is a low risk class.

Performance Scenarios

What happens if FundRock Management Company S.A. is unable to pay out?

What are the costs?

Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest and how long you hold the product. - In the first year, you would get back the amount that you invested (0 % annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario.
