

Type : This product is a share of an investment company qualifying as an undertaking for collective investment in transferable securities (UCITS). Term : This product has no maturity date. However, the Board of Directors may decide to close the product under certain circumstances. The Sub-Fund aims to achieve long term capital growth by principally investing to invest in equities of healthcare and healthcare related issuers Objectives : worldwide (including Emerging Markets). There is no guarantee that the Sub-Fund will achieve a positive return over this, or any other, period and you may not get back the original amount you invested. The Sub-Fund will invest, directly or indirectly, at least 80% of its net assets in equity and equity-type securities (such as depositary receipts, American Depositary Receipts, Global Depositary Receipts, etc.) of issuer worldwide, including real estate investment trust ("REITs"). The Sub-Fund is not constrained as to currency of denomination (which must be freely convertible), market capitalization, industrial sector or geography. ## WHAT ARE THE RISKS AND WHAT COULD I GET IN RETURN?

#### Cost over time

#### HOW LONG SHOULD I HOLD IT AND CAN I TAKE MY MONEY OUT EARLY?

The recommended minimum holding period: 5 years.

Redemptions are possible any day on which banks in Luxembourg and Zürich are open for business except for 24 December. In exceptional circumstances, your right to request the redemption of your investment may be limited or suspended.
