#### WHAT IS THIS PRODUCT?

Гуре :	This product is a share of an investment company qualifying as an undertaking for collective investment in transferable securities (UCITS).
Term :	This sub-fund has no maturity date. However, the board of directors may decide to close the sub-fund under certain circumstances.
Objectives :	The aim of the Sub-Fund is to provide long-term capital appreciation through selected investments in listed equity securities of companies involved the design, manufacture or sale of products and services in connection with the seas and water management sectors. The Sub-Fund may also hold ancillary liquid assets (i.e. bar deposits at sight, such as cash held in current accounts with a bank accessible at any time) up to 20% of its net assets for treasury purposes. The Sub-Fund will not invest more than 10% of its net assets in undertakings for collective investment. The Sub-Fund may use financial derivative instruments for hedging and/or for other purposes, including options, forwards, futures and/or swaps on Transferable Securities and/or other eligib assets as described in the prospectus. The Sub-Fund will not use efficient portfolio management techniques or Total Return Swaps (TRS). The Sub-Fund qualifies as an Article 8 product under SFDR.

#### **Risk indicator**
