WHAT IS THIS PRODUCT?

Type : This product is a share of an investment company qualifying as an undertaking for collective investment in transferable securities (UCITS).

Term : This sub-fund has no maturity date. However, the board of directors may decide to close the sub-fund under certain circumstances.

Objectives : The objective of the Sub-Fund is to provide its investors with capital growth, mainly by investing in units of Undertakings for the Collective Investment in Transferable Securities ("UCITS") and/or Undertakings for collective investment ("UCIs") offering different strategies and the philosophy of which is to achieve an absolute performance. At least two thirds of the assets, excluding cash, will be invested at all times in UCITS and/or UCIs having notably (but not limited to) the following alternative investment styles: "Long Short Equity", "Event-Driven", "Macro", "Relative-Value" and "Protection" (For detailed definition for each of these investment style, please refer to the prospectus).

The Sub-Fund's assets must be invested in at least three of these styles without any one of them accounting for more than 50% of the Sub-Fund's total net assets.

•The Sub-Fund may invest up to 20% of its net assets in money market instruments and time-deposits or UCIs. However, The exclusive object of which is the collective investment in money market instruments and the placing of deposits with credit institutions.

•The Sub-Fund shall not invest more than 30% of its net assets in units of other UCIs (other than UCITS).The Sub-Fund may also hold ancillary liquid assets (i.e. bank deposits at sight, such as cash held in current accounts with a bank accessible at any time) up to 20% of its net assets for treasury purposes.

•The Sub-Fund may invest in financial derivative instruments, including but not limited to FX forwards, for hedging and efficient portfolio management purposes.The Sub-Fund will not use efficient portfolio management techniques or Total Return Swaps (TRS). The Sub-Fund is actively managed and the investment objectives and strategy do not refer to a benchmark.

The Sub-Fund launched on 27/04/2021. The share class launched on 01/03/2022.

The currency of the Sub-Fund is EUR, the currency of this product is GBP.

Distribution Policy: Returns and gains are not distributed but are reinvested in the Fund.

Intended retail investor : This Sub-Fund is aimed more particularly at investors who wish to achieve capital growth by means of a dynamic diversification of their investments by investing mainly in units of UCITS and/or UCIs with a focus on various alternative strategies and styles, as further described above and have at least a 5 years investment horizon period. Investors are advised to invest only a part of their assets in such a Sub-Fund.

The risk indicator assumes you keep the product for 5 years The actual risk can vary significantly if you cash in at an early stage and you may get back less.

However, investors may suffer loss if the Sub-Fund or the depository is unable to pay out. There is no compensation or guarantee scheme in place which may offset, all or any, of this loss.

WHAT ARE THE COSTS?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

Cost over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- In the first year you would get back the amount that you invested (0% annual return)
- For the other holding periods we have assumed the product performs as shown in the moderate scenario

The recommended minimum holding period: 5 years.
