### Objectives and investment policy

The Fund's objective is to replicate, as closely as possible, the performance of the Stoxx® China A 900 Minimum Variance Unconstrained AM Index (the "Index"). The Fund is passively managed.

The Index consists of shares of Chinese companies which are traded on the two main stock exchanges of mainland China, the Shanghai Stock Exchange and the Shenzhen Stock Exchange. These shares are quoted and traded in renminbi (the official currency of the People's Republic of China) and are commonly referred to as A-shares. Constituents are selected and weighted with the aim of reducing the Index's risk, by reducing volatility i.e. the intensity and frequency of fluctuations of the Index values. Companies are also screened by how heavily they are traded on exchange. The Index currently consists of 156 constituents and the maximum weight per constituent is 8%. The Index is calculated in renminbi. The Index assumes that dividends of Index constituents are reinvested in the Index net of taxes.

In order to achieve its investment objective, the Fund will use a method of either physical or synthetic replication of the Index. The investment manager will decide between physical and synthetic replication on an ongoing basis, in the best interests of investors. At present, the fund uses physical replication.

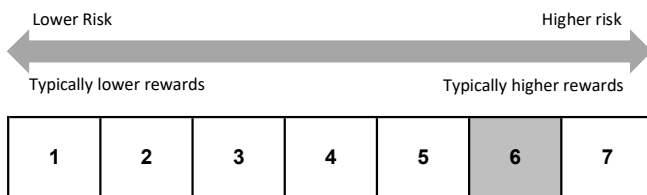
The Fund will replicate the Index physically by aiming to invest as far as possible in the constituents of the Index, in the same proportions in which they are included in the Index. In order to replicate the Index synthetically, the Fund will invest in a portfolio of securities (whose composition can be viewed at [marketaccessetf.com](http://marketaccessetf.com)), and enter into a derivative agreement (the "Swap Agreement") with a swap counterparty (the "Swap Counterparty"). Under the Swap Agreement, the Fund will exchange the performance of the portfolio of securities against the performance of the Index.

- You can buy or sell shares of the Fund through your stockbroker via the stock exchanges where the Fund is traded.

**Replication Risk:** The Fund may be unable to hold the constituents of the Index in the same proportions in which they are included in the Index, and there is no guarantee that the Fund will track the performance of the Index.

**Counterparty Risk:** There is a risk that the Swap Counterparty may default and the Fund may lose a potentially unlimited portion of its value.

**Volatility Risk:** The Fund tracks an Index comprising shares with low volatility characteristics. There is no guarantee that the Index or the Fund will have low volatility.

**Emerging market risk:** The Fund tracks an Index of emerging market shares. Emerging markets typically have a higher than average risk compared to investing in more established markets.

**Concentration risk:** Investment risk is concentrated in a single market. The value of the Fund is therefore affected by localised factors to a greater degree than other, broader based investments. Your investment may be affected by local market conditions including political, economic and regulatory developments in China.

**Currency risk:** Changes in foreign exchange rates may affect the value of your investment. The renminbi may be subject to greater fluctuations in value than the currency of more established economies.

**Operational Risk:** Failure of procedures or systems, as well as human error or external events associated with the Fund's management and/or administration, may cause losses to the Fund.

**Liquidity Risk:** Under certain circumstances your ability to buy or sell Fund shares via the stock exchanges where the Fund is traded may be limited.

**Stock Connect Risk:** As the Stock Connect collaboration between the Hong Kong, Shanghai and Shenzhen Stock Exchanges is a pilot programme, there remains uncertainty about the application and interpretation of the relevant regulations, which are subject to change and which may have retrospective effect. The status of the Fund's beneficial interest in securities acquired through the programme is untested and the Fund will be exposed to counterparty risk with respect to brokers and the Chinese central clearinghouse in relation to the handling of such securities under the programme.

## Charges for this Fund

The charges you pay are used to pay the costs of running the Fund including the costs of marketing and distributing it. These charges reduce the potential growth of your investment.

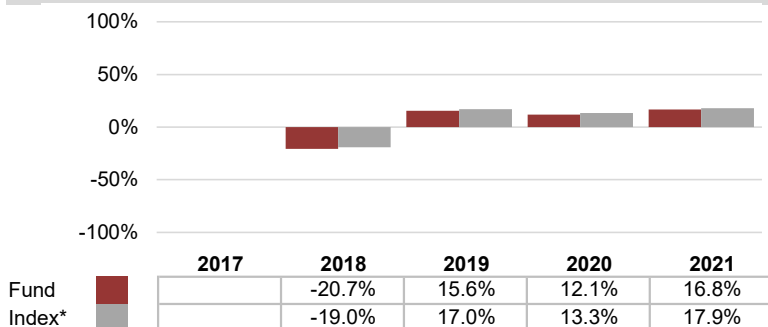
