What is this product?

Type:

This product is a UCITS Fund [authorised in Luxembourg and regulated by the Commission de Surveillance du Secteur Financier].

Term: This product is not subject to any fixed term.

Objectives:

The Fund is actively managed and aims to grow the value of your investment over the long term. The Fund will invest globally in a range of other investment funds.

The assets of investee funds will be varied and may include company shares, bonds issued by companies and governments (which are similar to loans that pay a fixed or variable rate of interest), cash and deposits, commodities (wheat, coffee, gold etc.) and other investments. Assets of these other funds will be from around the world and valued in different currencies, although mainly made up of companies in Europe or companies valued in Euro.

Holding recommendation: this Fund may not be appropriate for investors who plan to withdraw their money within three years of date of investment.

You can buy and sell shares on any day that is a business day in Luxembourg and the United Kingdom, and such transactions will be traded on the Fund's next available valuation date.

Prior to 1 October 2021 the Fund was known as the Harmony Portfolios Europe Diversified Fund. Prior to 20 March 2015 the Fund was known as the Harmony Portfolios Euro Balanced Fund.

Intended Retail Investor:

The Fund is offered to investors who may have basic or no knowledge and experience of investing in financial markets and also experienced investors. The Fund is intended for long-term investment, in line with the recommended holding period or longer. Investors should understand the risks involved, including the risk of losing capital invested and must evaluate the Fund's objective and risks in terms of whether they are consistent with their own investment goals and risk tolerances.



What are the risks and what could I get in return?

The risk indicator assumes you keep the product for 6 Years. The actual risk can vary significantly if you cash in at an early stage and you may get back less. You may not be able to cash in early. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as class 3 out of 7, which is a medium-low risk class. This rates the potential losses from future performance at a medium-low level, and poor market conditions are unlikely to impact the capacity of the fund to pay you.

Be aware of currency risk. You will receive payments in a different currency, so the final return you will get depend on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.

What happens if Momentum is unable to pay out?

The Management Company is responsible for administration and management of the Fund, and does not typically hold assets of the Fund (assets that can be held by a depositary are, in line with applicable regulations, held with a depositary in its custody network). The Management Company, as the manufacturer of this product has no obligation to pay out since the product design does not contemplate any such payment being made. However, investors may suffer loss if the Fund or the depositary is unable to pay out. There is no compensation or guarantee scheme in place which may offset, all or any, of this loss.

What are the costs?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

Costs over Time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- In the first year you would get back the amount that you invested (0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario.

How long should I hold it and can I take money out early?

Recommended holding period:

6 Years

This product has no required minimum holding period but is designed for long-term investment. Since the value of investments can rise and fall over differing time periods, you should have an investment horizon of at least 6 years when buying an investment of this type. The minimum recommended holding period is therefore 6 years. You can request to take out some or all of your money at any time. You can typically request to buy or sell shares in the Fund on any business day (as set out in the Fund's prospectus).
