What is this product?

Type:

This product is a UCITS Fund [authorised in Luxembourg and regulated by the Commission de Surveillance du Secteur Financier].

Term: This product is not subject to any fixed term.

Objectives:

The Fund is actively managed and aims to grow the value of your investment over the long term. The Fund will invest globally in a range of other investment funds.

The assets of investee funds will be varied and may include company shares, bonds issued by companies and governments (which are similar to loans that pay a fixed or variable rate of interest), cash and deposits, commodities (wheat, coffee, gold etc.) and other investments. Assets of these other funds will be from around the world and valued in different currencies, although mainly made up of companies in the UK or companies valued in Sterling.

You can buy and sell shares on any day that is a business day in Luxembourg and the United Kingdom, and such transactions will be traded on the Fund's next available valuation date.

Any income generated will be reinvested to grow the value of your investment. You can buy and sell shares on any day that is a business day in Luxembourg and the United Kingdom, and such transactions will be traded on the Fund's next available valuation date.

Intended Retail Investor:



However, investors may suffer loss if the Fund or the depositary is unable to pay out. There is no compensation or guarantee scheme in place which may offset, all or any, of this loss.

What are the costs?

Costs over Time
