What is this product?

Type:

This product is a UCITS Fund [authorised in Luxembourg and regulated by the Commission de Surveillance du Secteur Financier].

Term:

This product is not subject to any fixed term.

Objectives:

The Fund is actively managed and aims to grow the value of your investment over the long term, whilst minimising the possible reduction in the value of your investment. The Fund will invest globally in a range of other investment funds.

The assets of investee funds will be varied and may include company shares, bonds issued by companies and governments (which are similar to loans that pay a fixed or variable rate of interest), cash and deposits, commodities (wheat, coffee, gold etc.) and other investments. Assets of these other funds will be from around the world and valued in different currencies, although mainly made up of companies in the USA or companies valued in US Dollars.

You can buy and sell shares on any day that is a business day in Luxembourg and the United Kingdom, and such transactions will be traded on the Fund's next available valuation date.

Any income generated will be reinvested to grow the value of your investment. You can buy and sell shares on any day that is a business day in Luxembourg and the United Kingdom, and such transactions will be traded on the Fund's next available valuation date.



What happens if Momentum is unable to pay out?

The Management Company, as the manufacturer of this product has no obligation to pay out since the product design does not contemplate any such payment being made. However, investors may suffer loss if the Fund or the depositary is unable to pay out. There is no compensation or guarantee scheme in place which may offset, all or any, of this loss.

What are the costs?

Costs over Time

The tables show the amounts that are taken from your investment to cover different types of costs. Recommended holding period:

5 Years

This product has no required minimum holding period but is designed for long-term investment. Since the value of investments can rise and fall over differing time periods, you should have an investment horizon of at least 5 years when buying an investment of this type.

The minimum recommended holding period is therefore 5 years. You can request to take out some or all of your money at any time. You can typically request to buy or sell shares in the Fund on any business day (as set out in the Fund's prospectus).
