What is this product?

Type:

This product is a UCITS Fund [authorised in Luxembourg and regulated by the Commission de Surveillance du Secteur Financier].

Term: This product is not subject to any fixed term.

Objectives:

The Fund aims to to outperform the MSCI World Index over a rolling 3-year period by investing in a diversified portfolio substantially consisting of shares (equities) listed on international stock exchanges.

The Momentum GF Global Equity Fund will be actively managed and may be substantially invested in securities contained in the MSCI World Index as a result of such active management. However, the performance of the MSCI World Index will be without direct impact on the portfolio of the Momentum GF Global Equity Fund.

The Fund may also invest in other non-equity investments as long as sufficient of the non-equity asset class risk is hedged away using derivatives instruments to keep the Fund within its investment restrictions.

Intended Retail Investor:

The Fund is offered to investors who may have basic or no knowledge and experience of investing in financial markets and also experienced investors. The Fund is intended for long-term investment, in line with the recommended holding period or longer. Investors should understand the risks involved, including the risk of losing capital invested and must evaluate the Fund's objective and risks in terms of whether they are consistent with their own investment goals and risk tolerances.

What are the risks and what could I get in return?

Risk indicator





The risk indicator assumes you keep the product for 7 Years. The actual risk can vary significantly if you cash in at an early stage and you may get back less. You may not be able to cash in early. What happens if Momentum is unable to pay out?

The Management Company, as the manufacturer of this product has no obligation to pay out since the product design does not contemplate any such payment being made. However, investors may suffer loss if the Fund or the depositary is unable to pay out. There is no compensation or guarantee scheme in place which may offset, all or any, of this loss.

What are the costs?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

Costs over Time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- In the first year you would get back the amount that you invested (0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario.

How long should I hold it and can I take money out early?

Recommended holding period:

This product has no required minimum holding period but is designed for long-term investment. Since the value of investments can rise and fall over differing time periods, you should have an investment horizon of at least 7 years when buying an investment of this type.

The minimum recommended holding period is therefore 7 years. You can request to take out some or all of your money at any time. You can typically request to buy or sell shares in the Fund on any business day (as set out in the Fund's prospectus).
