What is this product?

The Momentum GF Global Fixed Income Fund aims to outperform the JP Morgan Global Government Bond Index unhedged in USD over a rolling 3 year period.

The Fund is actively managed and may be substantially invested either directly or indirectly in fixed income securities contained in the JP Morgan Global Government Bond Index. However, the performance of the JP Morgan Global Government Bond Index will be without direct impact on the portfolio of the Momentum GF Global Fixed Income Fund.

The Fund may also invest in money market instruments, fixed income funds and may also use derivatives for efficient portfolio management including futures, options, CDS, forwards and swaps.

However, investors may suffer loss if the Fund or the depositary is unable to pay out. There is no compensation or guarantee scheme in place which may offset, all or any, of this loss.

What are the costs?

Costs over Time

How long should I hold it and can I take money out early?

Recommended holding period:

This product has no required minimum holding period but is designed for long-term investment. Since the value of investments can rise and fall over differing time periods, you should have an investment horizon of at least 3 years when buying an investment of this type.
