What is this product?

Investment Company (SICAV), Luxembourg

This sub-fund has no maturity date. However, the board of directors may decide to close the sub-fund under certain circumstances.

Objectives

The sub-fund invests mainly in company shares (equities) or instruments related to company shares. The primary focus of the sub-fund is on the Swedish equity market, but the sub-fund may invest in all the Nordic equity markets. The sub-fund may also invest up to 10 percent of its assets in Nordic in fixed income or money market instruments, cash and cash equivalents. The sub-fund may also use derivatives to achieve its investment objective or to mitigate risks. The sub-fund's investment policy contains broad environmental, social, and governance criteria such as climate action, decent work and well-being, sustainable cities and commodities etc.

The UN SDGs (Sustainable Development Goals) form the basis for the subfund's promotion of environmental and social characteristics. The Investment Manager integrates these goals into the sub-fund's investment strategy to better manage risk, generate sustainable long-term returns, and promote environmental or social characteristics. The Investment Manager uses negative screening of assets for exclusion from the investment universe. Benchmark: The portfolio is actively managed on a discretionary basis without reference to a benchmark.

Intended retail investor

The sub-fund is offered to investors who may have basic or no knowledge and experience of investing in financial markets and also experienced investors and is intended for investors seeking exposure to the Nordic equity markets in general and appreciates the long term effects of the active approach that is

synonymous with the investment style of the management team. Active management for us means large deviation from any benchmark when it comes to position size. The general portfolio turnover of the sub-fund could also be high, due to trading activities. The single purpose of the active management approach is to deliver a competitive alpha. This sub-fund may not be appropriate for investors who plan to withdraw their money within 7 years.

Other information

Depositary: Skandinaviska Enskilda Banken. AB (publ) - Luxembourg Branch

Dividend income: This class is a capitalisation class meaning that income is reinvested.

Conversion right: The investor has the right to convert his investment in shares in one sub-fund for shares in the same sub-fund or in another sub-fund. The investor can obtain information about how to convert in the prospectus of the fund.

Segregation: The assets and liabilities of a sub-fund are segregated pursuant to the law so that the commitments and liabilities of one sub-fund do not affect the other sub-funds.

What are the risks and what could I get in return?

Risk indicator



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 4 out of 7, which is a medium risk class. This rates the potential losses from future performance at a medium level, and poor market conditions could impact our capacity to pay you.

Be aware of currency risk. You may receive payments in a currency that differs from your reference currency, so the final return you will get depends on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.

What happens if FundRock Management Company S.A. is unable to pay out?

What are the costs?

Costs over time
