What is this product?

Investment Company (SICAV), Luxembourg

This sub-fund has no maturity date. However, the board of directors may decide to close the sub-fund under certain circumstances.

Objectives

The sub-fund aims to generate a stable return over time, combined with a moderate volatility, regardless of the direction of the capital markets. In order to achieve its objective, the sub-fund may invest in Nordic company shares (equities) and interest bearing instruments, applying a combination of different strategies. Equity exposure may be achieved through different types of instruments including derivatives.

The sub-fund will also hold short position in equities through derivatives in order to hedge the equity exposure. Exposure to the interest markets will be achieved through interest bearing instruments, derivative and cash related instruments. Equity exposure will be hedged in various proportions and the exposure to the interest markets will take up a large part of the investment activities.

The sub-fund may also invest up to 10 percent of its assets in other funds. The sub-fund may also use derivatives, to achieve its investment objective or to mitigate risks. The sub-fund's investment policy contains broad environmental, social, and governance criteria such as climate action, decent work and well-being, sustainable cities and commodities etc. The UN SDGs (Sustainable Development Goals) form the basis for the sub-fund's promotion of environmental and social characteristics. The Investment Manager integrates these goals into the sub-fund's investment strategy to better manage risk, generate sustainable long-term returns, and promote environ-mental or social characteristics. The Investment Manager uses negative screening of assets for exclusion from the investment universe. Benchmark: The portfolio is actively managed on a discretionary basis without reference to a benchmark.

Intended retail investor

The sub-fund is a Multi Strategy Fund with an absolute return profile. The subfund's ambition is to deliver absolute returns regardless of the general direction of the Nordic Capital Markets. The sub-fund is aimed at investors who seek a blend of exposure to Nordic Corporations, both in the form of equity participation and credit exposure through fixed income securities (in particular but not limited to corporate bonds). The sub-fund will carry a risk that is considerable lower than the volatility of the Nordic Stock Markets. The return of the sub-fund is generated from a selection of investments in fixed income instruments, corporate bonds as well as the equity markets. The sub-fund's return may therefore have a high or low correlation with the return of the Nordic Equity Markets. The sub-fund may also carry a positive as well as a negative net exposure to the equity market. This sub-fund may not be appropriate for investors who plan to withdraw their money within 3 years.

Dividend income: This class is a capitalisation class meaning that income is reinvested.

Conversion right: The investor has the right to convert his investment in shares in one sub-fund for shares in the same sub-fund or in another sub-fund. The investor can obtain information about how to convert in the prospectus of the fund.

Segregation: The assets and liabilities of a sub-fund are segregated pursuant to the law so that the commitments and liabilities of one sub-fund do not affect the other sub-funds.

The reference currency of the sub-fund is expressed in SEK. The currency of the share class is expressed in EUR. For this share class, the foreign-exchange risk of the share currency is systematically hedged against the sub-fund's reference currency.

What are the risks and what could I get in return?

Risk indicator



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 3 out of 7, which is a medium-low risk class

What happens if FundRock Management Company S.A. is unable to pay out?

What are the costs?

Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. How long should I hold it and can I take money out early?

Recommended holding period: 3 years

Redemptions are possible on each full bank business day in Luxembourg. In exceptional circumstances, your right to request the redemption of your investment may be limited or suspended.
