# What is this product?

#### Type:

The Fund is a sub-fund of Oaktree (Lux.) Funds (the "SICAV"), an investment company with variable capital structured as an umbrella fund offering a range of sub-funds.

## Term:

This product is not subject to any fixed term.

### **Objectives:**

The investment objective of the Fund is to achieve superior risk-adjusted returns by investing primarily in high yield bonds issued by European issuers and on an ancillary basis in high yield bonds denominated in European currencies issued by North American issuers. The Fund is actively managed with reference to the benchmark ICE BofAML Global HY European Iss. Non-Fin. Excl. Russia (TR) (EUR-H).

While the Fund has a reference benchmark, it is actively managed by implementing the investment philosophy and process described herein and has an ample degree of freedom to deviate from the benchmark. The Fund may invest up to 10% of its NAV in Distressed Securities.

The Fund may use derivatives for hedging purposes.

### Intended retail investor:

The Fund may be appropriate for investors who want to invest primarily in high yield bonds issued by European issuers and high yield bonds denominated in European currencies issued by North American issuers. It is designed for long-term investors who understand and accept the risks of the Fund, and are able and prepared to sustain losses.

The Fund's Depositary Bank is State Street Bank International GmbH, Luxembourg Branch.

The assets of the Fund are held in safekeeping by its Depositary, State Street Bank International GmbH, Luxembourg Branch in line with applicable regulations. In the event of the Depositary's insolvency, the Fund may suffer a financial loss, however, this risk is mitigated to a certain extent by the fact the Depositary is required by law to segregate its own assets from the assets of the Fund. There is no investor compensation or guarantee scheme in place which may offset, all or part, of this loss.

# What are the costs?
