What is this product?

Investment Company (SICAV), Luxembourg

This sub-fund has no maturity date. However, the manufacturer may decide to close the sub-fund under certain circumstances.

The sub-fund aims to achieve the best possible return, relative to the risk taken

The sub-fund invests in fixed income and fixed income related securities issued by corporations, agencies, governments and municipalities. The debt securities may include subordinated, hybrids and convertible bonds. Investments are expected to give the sub-fund a higher risk and return than traditional securities due to a higher credit risk. The sub-fund primarily invests in securities issued by companies domiciled or with a presence in the Nordic region. average interest rate duration of the sub-fund's portfolio shall be between 0 and 4 years.

What are the costs?
