What is the product?

Type: Undertaking for Collective Investment in Transferable Securities (UCITS) under European Directive 2009/65/EC. An investment company with variable capital (société dinvestissement à capital variable or "SICAV") under Luxembourg law.

Term: This product is not subject to any fixed term.


Objectives

The sub-fund's objective is to deliver a greater total return than the Consumer Price Index (CPI) measure of inflation + 3%, after fees, over any rolling five-year period by investing with the Liquidity, Equity-type risk and Diversifiers assets (LED) framework developed by the investment manager. The sub-fund aims to deliver this return with no more than two-thirds of the volatility of the FTSE Developed Market Index. There is no guarantee that the sub-fund will achieve a positive return over this, or any other, period and you may not get back the original amount you invested.

Intended Retail Investor: This product targets Retail and Professional investors and as a minimum requirement, is suited to a first time investor with a basic knowledge of investments. This product targets investors who intend to invest their money for a minimum period of 5 years. Rathbones defines the minimum recommended holding period of 5 years as Long Term. This product is appropriate for investors who have a risk appetite compatible with the SRI of the product as defined in the Prospectus. This product may be distributed as follows: on an execution only basis without a suitability assessment; with investment advice; or, as a component of a managed portfolio.

The depositary is HSBC Continental Europe, Luxembourg. What are the risks and what could I get in return? Risk indicator

The risk indicator assumes you keep the product for a minimum of 5 Years. You may not be able to sell your product easily or may have to sell at a price that significantly impacts on how much you get back.

We have classified this product as class 3 out of 7, which is a mediumlow risk class. This rates the potential losses from future performance at a medium-low level, and poor market conditions are unlikely to impact the capacity of the fund to pay you.

Be aware of currency risk. You may receive payments in a different currency than the Sub-Fund's base currency, so the final return you get may depend on the exchange rate between the two currencies. This risk is not considered in the indicator above.
