What is the product?

Type: Undertaking for Collective Investment in Transferable Securities (UCITS) under European Directive 2009/65/EC. An investment company with variable capital (société d'investissement à capital variable or "SICAV") under Luxembourg law.

Term: This product is not subject to any fixed term.

Objectives:

The sub-fund's objective is to deliver a greater total return than the Consumer Price Index (CPI) measure of inflation + 3%, after fees, over any rolling five-year period by investing with the Liquidity, Equity-type risk and Diversifiers assets (LED) framework developed by the investment manager. The sub-fund aims to deliver this return with no more than two-thirds of the volatility of the FTSE Developed Market Index. There is no guarantee that the sub-fund will achieve a positive return over this, or any other, period and you may not get back the original amount you invested.

Intended Retail Investor: This product targets Retail and Professional investors and as a minimum requirement, is suited to a first time investor with a basic knowledge of investments. This product targets investors who intend to invest their money for a minimum period of 5 years. Rathbones defines the minimum recommended holding period of 5 years as Long Term. This product is appropriate for investors who have a risk appetite compatible with the SRI of the product as defined in the Prospectus. This product may be distributed as follows: on an execution only basis without a suitability assessment; with investment advice; or, as a component of a managed portfolio.

The depositary is HSBC Continental Europe, Luxembourg. Further information regarding the Fund, all available Sub-Funds and share classes, including copies of the prospectus, annual and half yearly report and accounts, can be obtained free of charge (in English and other required languages) from the registered office of the Company, 4, rue Peternelchen, L-2370, Howald, Grand Duchy of Luxembourg.

Be aware of currency risk. You may receive payments in a different currency than the Sub-Fund's base currency, so the final return you get may depend on the exchange rate between the two currencies. This risk is not considered in the indicator above.

The risk indicator assumes you keep the product for a minimum of 5 Years. You may not be able to sell your product easily or may have to sell at a price that significantly impacts on how much you get back.

We have classified this product as class 4 out of 7, which is a medium risk class. This rates the potential losses from future performance at a medium level, and poor market conditions could impact the capacity of the fund to pay you.

What are the costs?
