

	 The Fund will invest globally in the shares of companies in sectors identified by the Investment Manager as providing solutions to environmental sustainability challenges. There is no predetermined focus on business sector or geography although concentrations may emerge through stock selection. Under normal circumstances, the Fund will hold cash on deposit up to 10% of the Net Asset Value of the Fund.
